4a (Code:) (Expenses \$ 664,309. including grants of \$) (Revenue \$ 50,693.) To eliminate diaper need and raise awareness of the basic health need for diapers in the community. In 2020, the diaper distribution program distributed 2,290,310 diapers into the Greater Cincinnati Area. The retail value of the diapers donated to families in need was \$687,093. The diapers went to an average of 4,000 children each month to help ease the burden of diaper need. Our period supply distribution program distributed 550,838 period products. We piloted an adult incontinence supply program that distributed 7,791 products to 50 seniors each month. 1,274 unique volunteers completed 4,706 service hours to ensure program growth and success.
